

**BUDGET & APPROPRIATION  
HOMER TOWNSHIP HIGHWAY DEPARTMENT  
ORDINANCE NUMBER: HTRD-06172024**

AN ORDINANCE APPROPRIATING for all road purposes for the **HOMER TOWNSHIP** Highway Department, WILL County, Illinois, for the fiscal year beginning **April 1, 2024**, and ending **March 31, 2025**.

BE IT ORDAINED by the Board of Trustees of **HOMER** Township, **WILL** County, Illinois, as follows:

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of the **HOMER TOWNSHIP** Highway Department, be and the same are hereby appropriated for the road purposes of the **HOMER TOWNSHIP** Highway Department, WILL County, Illinois, as hereinafter specified for the fiscal year beginning **April 1, 2024** and ending **March 31, 2025**.

SECTION 2: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds:

**EQUIPMENT & BUILDING FUND  
GENERAL ROAD FUND**

SECTION 3: That the amount appropriated for Road Purposes for the fiscal year beginning **APRIL 1, 2024** and ending **MARCH 31, 2025** by fund shall be as follows:

<b>EQUIPMENT &amp; BUILDING FUND:</b>	<b>\$</b>	<b>240,485.00</b>
<b>GENERAL ROAD FUND:</b>	<b>\$</b>	<b>1,810,411.00</b>
<b>TOTAL APPROPRIATIONS:</b>	<b>\$</b>	<b>2,050,896.00</b>

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund shall be divided among the several objects and purposes specified, and in particular amount stated for each fund respectively in Section 2 constituting the total appropriations in the amount of **TWO MILLION FIFTY THOUSAND EIGHT HUNDRED NINETY-SIX & 00/100 (\$2,050,896.00)** for the fiscal year beginning







